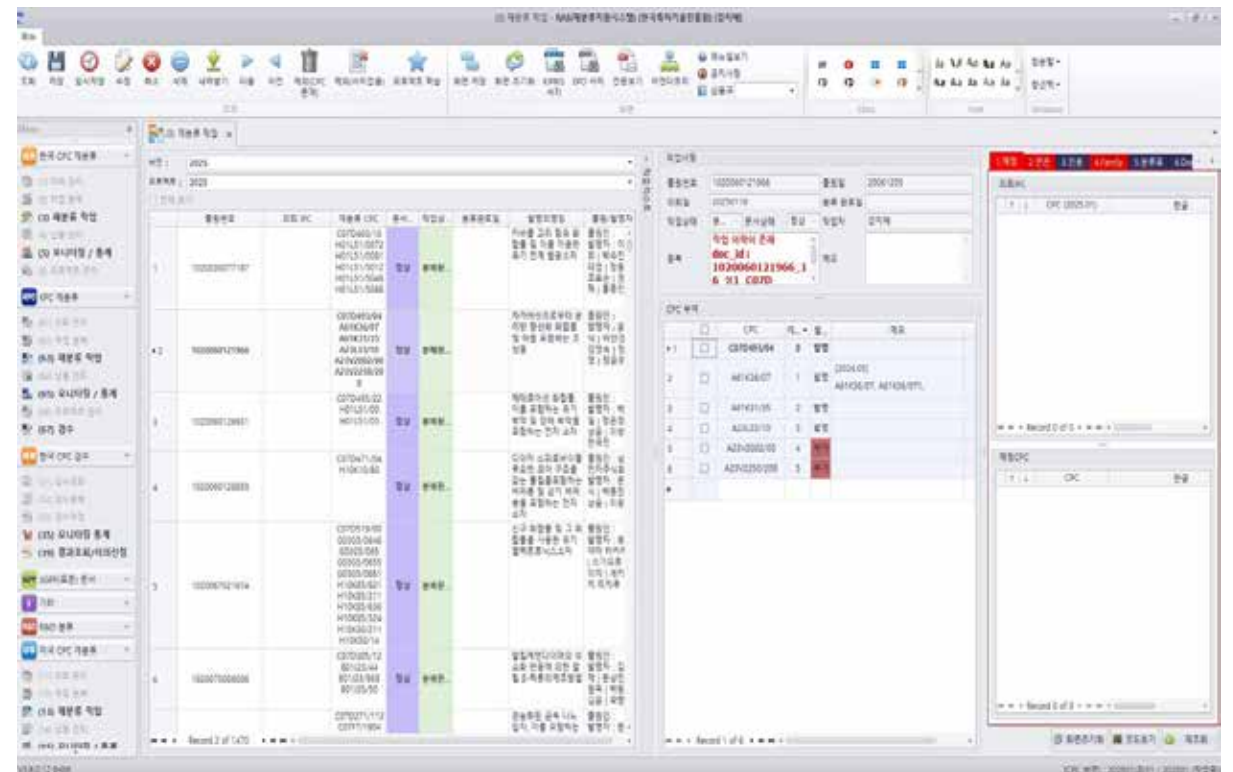

CPC Classification and Search

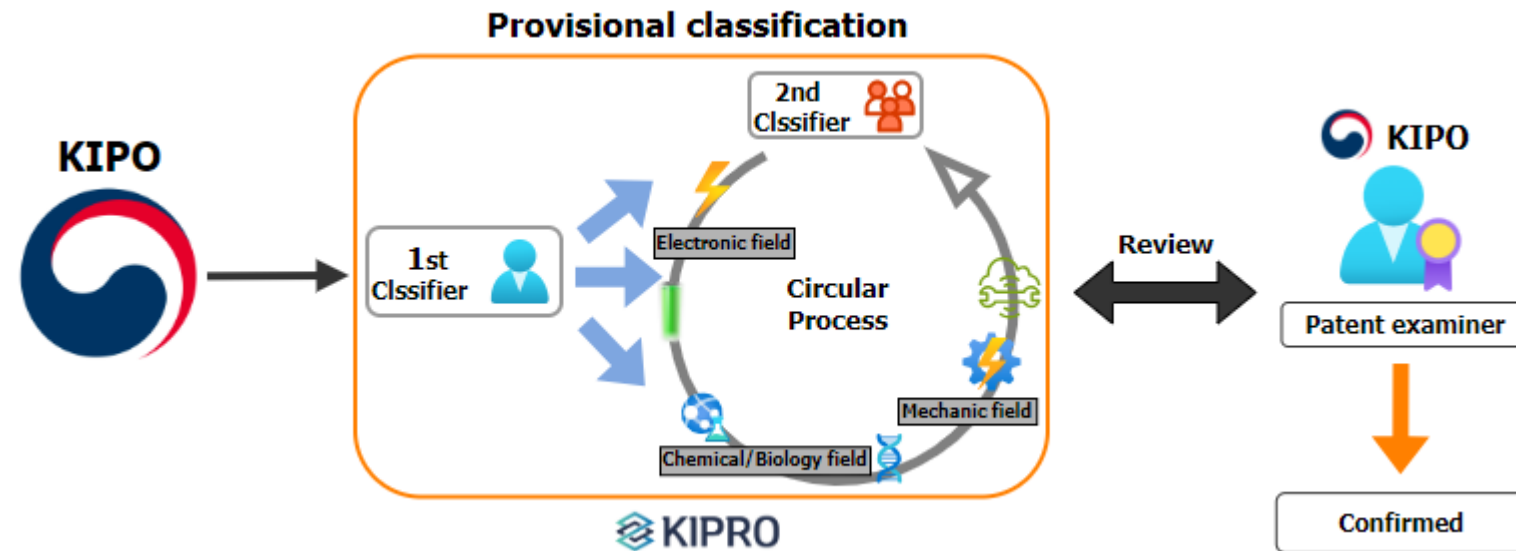
- Across **all CPC areas**, **KIPO uses our own systems** to assign classifications to **all types of documents**.
- KIPO has **two classification systems for front/backfiles** individually.
- **When searching for prior art** using our own system, **KIPO recommends using CPC**.

<A System for classifying back files only>



CPC Quality Assurance Process

- **KIPRO** conducts **to classify provisionally** then **KIPO reviews and confirms**.
 - If a patent examiner finds some errors, KIPRO conducts the classification again.
- To ensure CPC quality, **KIPO manually inspects randomly sampled documents** also **KIPRO** has a **circular process** for improving accuracy.



CPC Training

- Our classifiers are **trained through the CPC-training program provided by EPO** and **expert technical lectures**.

CPC Implementation

- **KIPO Began to assign CPC** to newly filed applications from **January 2015**
- In KIPO, **CPC is** effectively utilized as **a useful tool** * for efficient search and statistical analysis.
 - * Prior art search Application trend statistics Technology-based task allocation
- **KIPO is spending** a significant **budget on** the implementation and operation of CPC.
 - Classification of front file Reclassification of back file Operation of classifiers, etc.

CPC Implementation

- KIPO immediately applies the updated CPC scheme to front files.
- KIPO applies the updated CPC scheme to back files on an annual basis.
- In KIPO, the reclassification of 2.9 millions back files was completed by 2019.
- In KIPO, since 2020, almost all reclassification has been based on the updated CPC.

- KIPO provides the CPC documents translated into Korean and immediately applies the CPC updates in Korean as well.

CPC Data Exchange

- KIPO exchanges CPC data with the EPO in accordance with the Korea-EPO data exchange MOU signed in December 2012.
- KIPO exchanges data of front files and back files with the EPO every month.
- KIPO immediately applies the exchanged data, and there are no experience issues in this process.
