

Description

This tutored course addresses the topics of "opposition" and appeal". It gives you the opportunity to exchange interactively with EPO opposition examiners and board of appeal (BoA) members, who will present examples illustrating the practical application of legal texts in their daily work. Based on exercises, participants will gain insights into what this work involves, such as deciding on the best suitable action as a member of an opposition division, drafting the chosen action (communication, summons, direct decision) and a communication in appeal.

The EPO and BoA tutors will discuss the exercises (assignments) in two live sessions. An online forum will enable participants to interact with each other and the tutors.

The online course starts on 16 September and ends on 27 September 2024.

Technical requirements

The online sessions will be held on Zoom.

Duration

Five hours of online sessions plus five hours of self-study.
