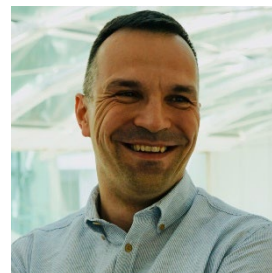

He successfully transformed Rimac's IP legal team, manages 100+ IP assets, and supported the €500 million Series D funding round. A lawyer with an LLM from CEIPI, he is also a certified mediator.
