Considering that (a) importing XML information into internal IP management system can (1) decrease cost for data entry, (2) keep information recent and accurate, and (b) roughly estimated cost for reporting new application filings, office actions, etc. on IP5 cases is about 472MUS\$/year, the following three items in the table were proposed:

## **2. Holding Meetings with Tool Venders**


