- Understanding discrepancy of IP laws and Proper suggestion to IP offices

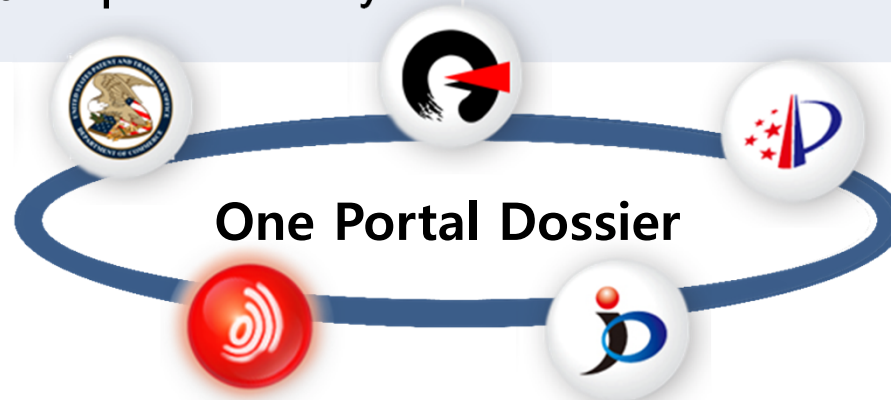
In-depth interview about two components

Active (Cross Filing)

- Acceptable IP5 patent application without language barrier
- Permission scope of machine translation
- Possibility of standardization for prosecution procedure
- Utilization of CCD (autonomous exchange)
- Utilization of united examination report
- Application fee is reasonable through GD
- Financial transaction (various payment tools)
- Reliable designated or certified patent attorney

Passive (OPD)

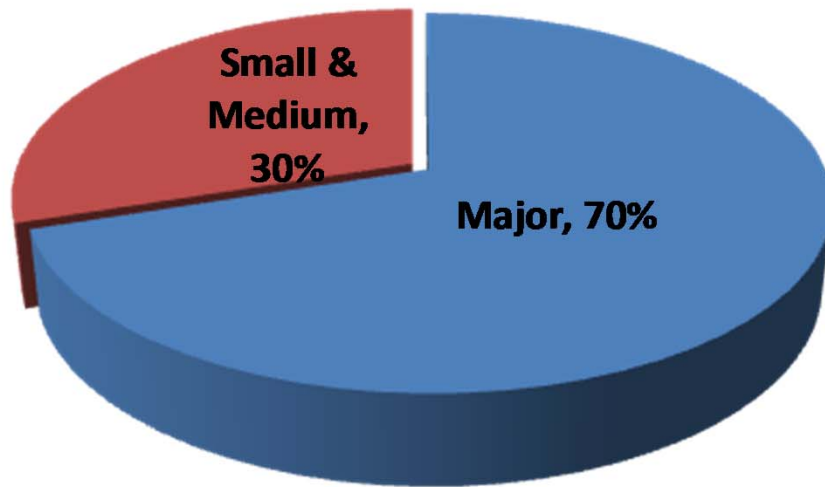
- Scope of publication (pre-publication, the 3rd opinion,
- Negative effect from sharing of family patent (increase of cited document, rejection rate, etc.)
- Standardization of applicant's name
- Status of patent right
- Utilization of machine translation (against specialized translation)

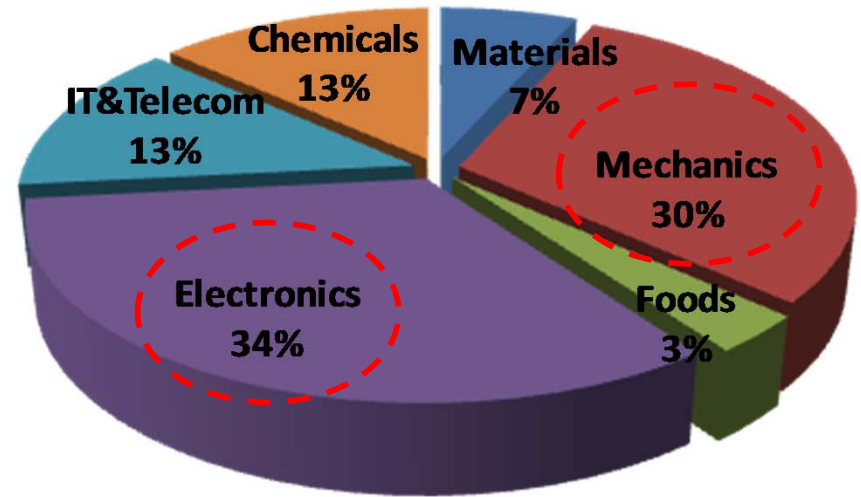

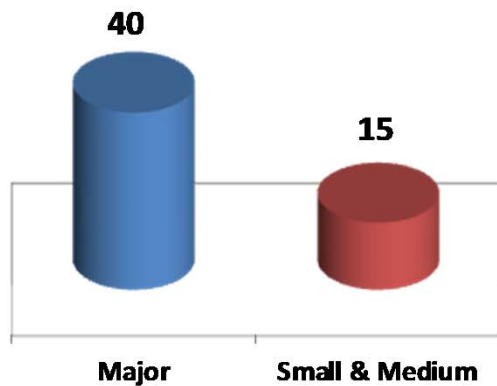
Size of Interviewee's Company



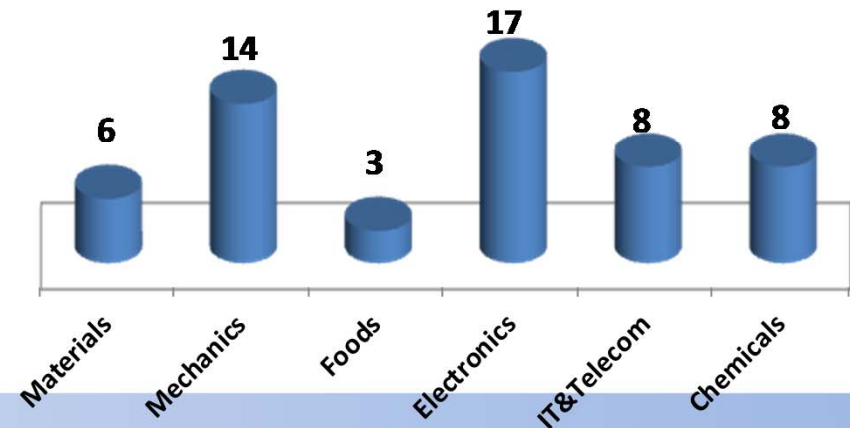
Industrial Field of Interviewees

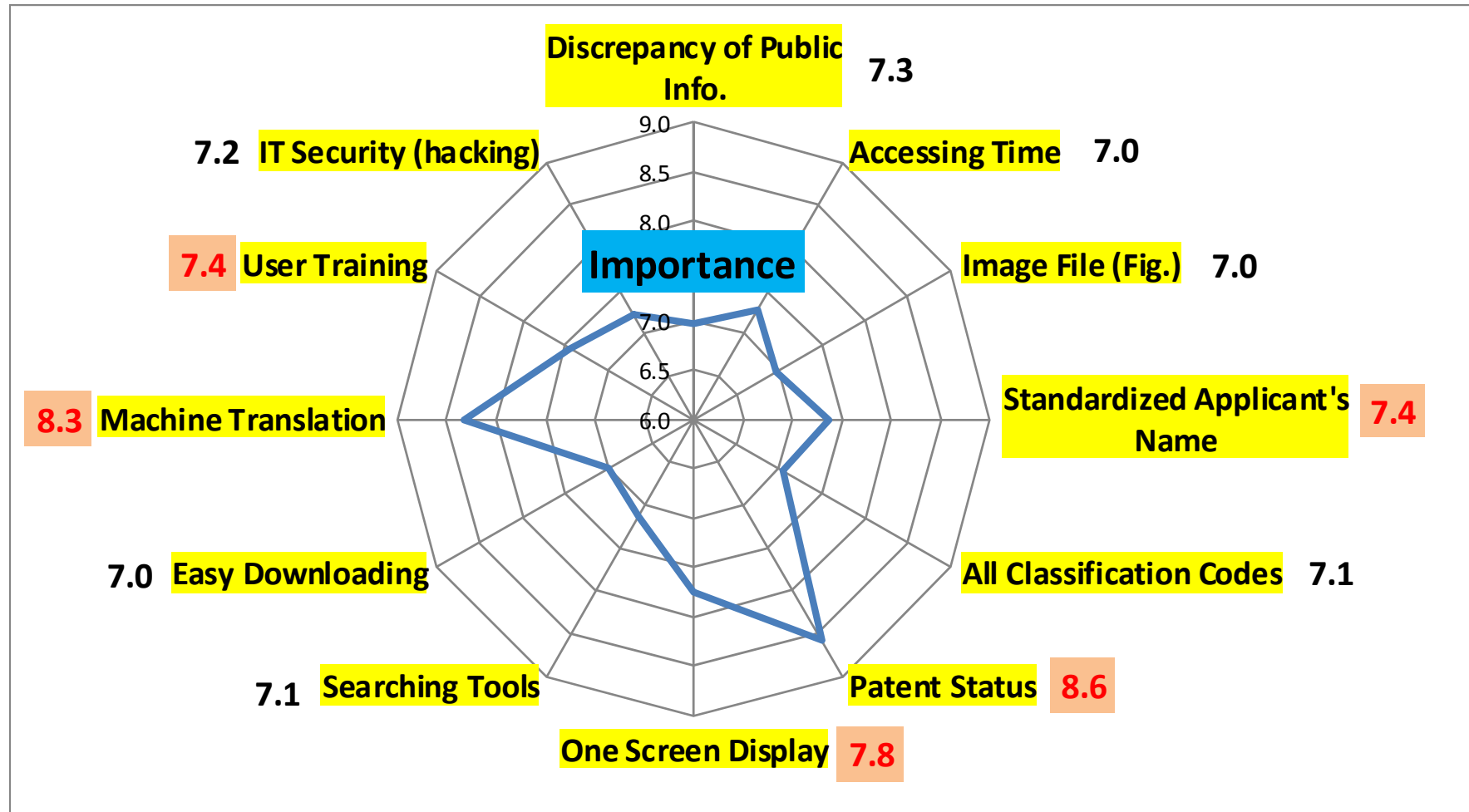

Summary 1

Desirable requirement from KINPA user on passive component are

- To standardize applicant's name
- To provide the status of patent rights with real-time updating
- To materialize machine translation without additional cost
- To be observable one screen view
- To strengthen user training via online and offline
- To shorten discrepancy of public patent information (non-patent documents, opinion document, search report of prior art, etc.)
- To protect IT security against illegal hacking
- Others....

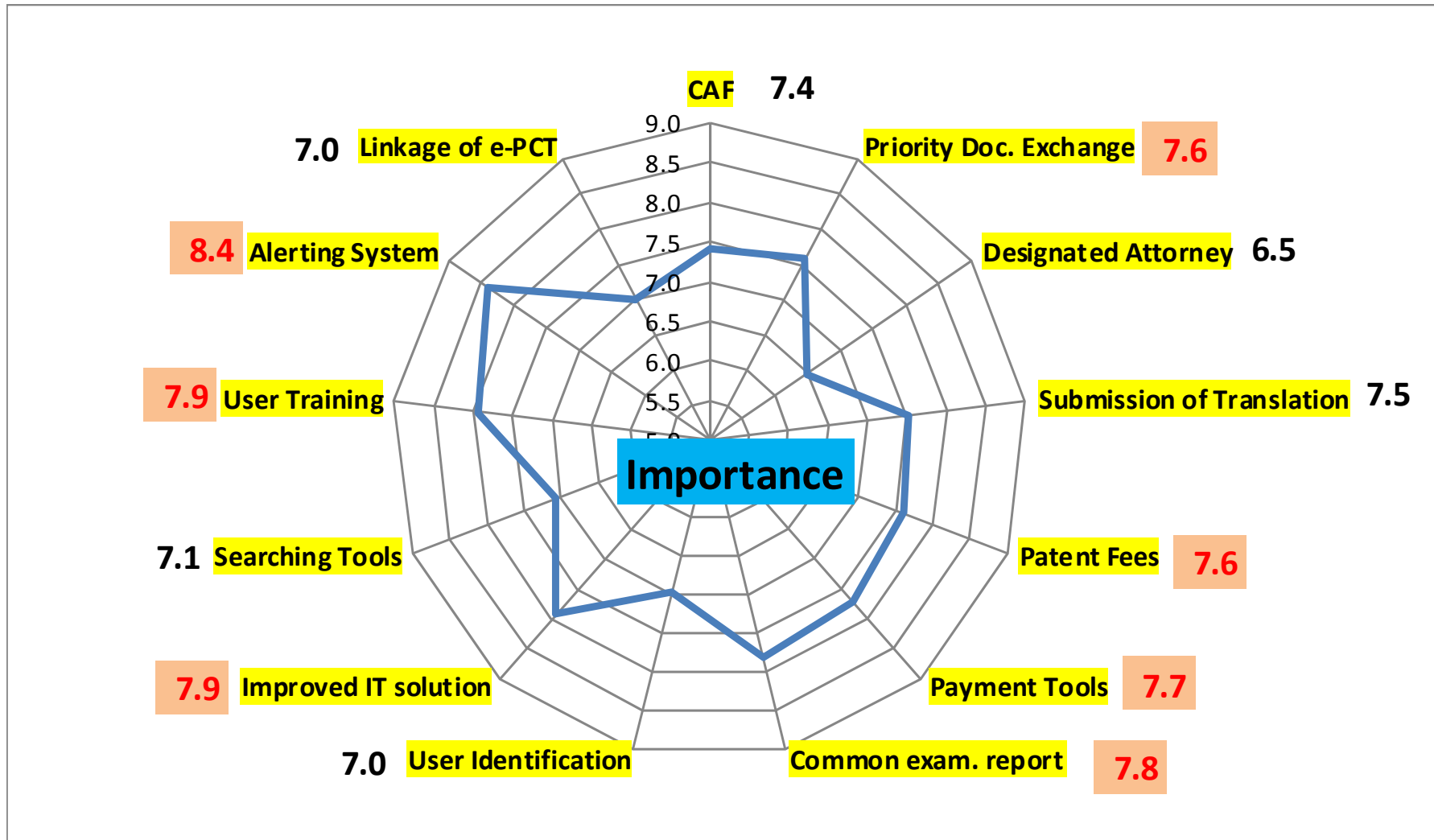

Summary 2

Desirable requirement from KINPA user on active component are

- To provide alerting system like EPO Register Alert System
- To utilize common examination report aggressively (is GD necessary?)
- To strengthen user training via online and offline
- To improve independent IT system for user (and designated) authentication
- To suggest reasonable patent fees and various payment tools
- To reduce user's burden significantly for PDX as well as translated document
- To exchange document based on API
- To standardize CAF(distinctive applicant's code, designed attorney's code, etc.)
- To match with user IP intranet for submission of filing documents based on API
- To protect IT security against illegal hacking
- To be limited uncertified designated person in case of cross-filing
- Others....
