

#### **IP5 Industry involvement**

- 2012: 5th IP5 Heads of Office meeting in Corsica -> IP5 Offices invited industry representatives from the five regions to participate
- Today's channels of interaction:
  - annual meeting between the IP5 Heads of Office and IP5 Industry
  - Global Dossier Task Force (since 2013)
  - Industry Consultation Group (since 2017)

Open and ongoing dialogue allows the IP5 Offices to respond to industry's needs and develop appropriate initiatives

#### **Global Dossier**

- In January 2013, at the first IP5 Global Dossier Task Force meeting, IP5 Industry defined their vision for retrieval of patent information at the IP5 level
- Global Dossier aggregates the prosecution history (file wrapper data) of the IP5 family members of an application in a single location
- Great value for examiners and users:
  - IP5 examiners can exchange work results which contributes to the quality of work
  - Users save costs and time when inspecting files
- Global Dossier brought positive results to all five offices and demonstrates the benefits of open co-operation with industry

#### **Common Citation Document**

- The Common Citation Document (CCD) provide single point access to upto-date citation data relating to the patent applications of the IP5 Offices
- First launched in November 2011, the CCD today offers access to 41.3 million search reports results of more than 30 patent authorities giving access to 427 million cited records
- Benefits:
  - consolidates the prior art cited by all participating offices for the family members of a patent application
  - enables users to visualise on a single page the search results for the same invention produced by several offices

### **IP5 Patent Prosecution Highway**

- Launched in early 2014, the IP5 Patent Prosecution Highway (PPH) provides easier access to the patent system
- Fast-track patent examination procedures at the IP5 Offices enable users to obtain patents more quickly and efficiently
- Benefits:
  - allows applicants to obtain corresponding patents faster and more efficiently
  - permits each office to exploit the work previously done by the other office

### **IP5 practice alignment**

- Since 2012, the Patent Harmonization Expert Panel (PHEP) has been exploring the potential for aligning procedural aspects of the patent application and granting process among the IP5 Offices
- Benefits:
  - more transparency and predictability
  - reduced workload for users and offices
- PHEP work on unity of invention, citation of prior art and written description/sufficiency of disclosure successfully concluded in 2019
  - Uniform application of unity of invention standard embedded in the PCT to international applications
