WIPO released the fourth draft on Legal Status Data Standard on November 16, 2016, and the Standard is expected to be approved in next CWS meeting.



IP5 Heads Meeting, May 2016:

IP5 offices approved the enhanced scope document of the Legal Status.

#### **Conclusions**

- All offices generally agree with the WIPO Standards and most offices suggest to focus on key events currently.
- All offices confirm their readiness to finish mapping before next DH meeting in April, 2017.
- All offices could agree on the Legal Status Common Categories & Prosecution Model no later than June 2017.
- Offices have different opinions towards data exchange means and further discussions are needed.

### **Next Step**

- Position of the Property IP5 offices agreed to finish mapping of stage, state and key events before Deputy Heads meeting to be held in April 2017.
- IP5 offices also agreed to reach a consensus on the Legal Status Common

  Categories & Prosecution Model, ideally with an agreement on detailed events in
  the Standard, in the next 2 months.
- Prosecution Model are approved.
