


- Offices have improved the convenience of e-filing.

 - ✓ Applicant's information (e.g., ID) : For Filtering
 - ✓ International Patent Classification(IPC): For Filtering / Machine learning
 - ✓ Citation List: For Filtering / Machine learning

Proposal

- JPO hopes to reach consensus on developing Mapping Matrix in IP5 Heads meeting.
- JPO proposes the disclosure of Matrix to Users and CWS
 using IP5 Web page / WIPO wiki.

- 1. The data which does not appear in current samples
 - ✓ The number of information statement from third party
 - ✓ The number of interview
 - ✓ The number of Trial
 - ✓ The number of filing Judgement
 - ✓ Existence of inspection

- 2. The data which is needed to be calculated by either Office or User
 - ✓ Expiration date of the title
 - ✓ The period of extending patent right

 - Share Mapping Matrix with WIPO's CWS
 - Cooperate with API standard
- ✓ Discuss the format of data
 - Appropriate data format for providing
