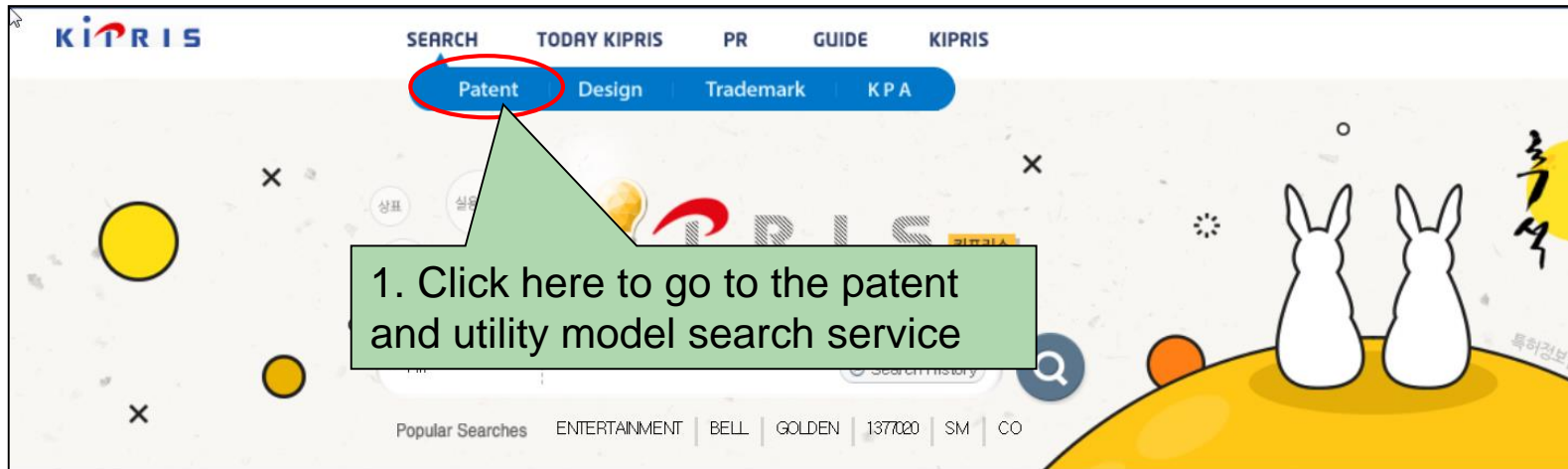


# RETRIEVING INFORMATION ON PATENT TERM EXTENSIONS IN KIPRIS



**NOTE: In Korea, there are two types of term extensions:**

**Slides 2-6: Patent term extension similar to SPCs (supplementary protection certificates)**

- for pharmaceutical or agrochemical patents
- for up to 5 years
- one extension may be obtained per patent

**Slides 7-13 Patent term adjustments for delays in examination procedure**

for applications filed from March 2012 onwards

- in case of delay caused by patent office
- for all technical fields
- granted for the period which exceeds either three years from examination request or four years from filing (whichever is longer)
