Most recently, he served as the Director of the Office of Governmental Affairs as a member of the Executive Management team at the U.S. Patent and Trademark Office (USPTO) from 2009 - 2019. Prior to that role, Mr. Colarulli served as Director of Government Relations and Legislative Counsel for the Intellectual Property Owners Association (IPO). He was born in Rhode Island and is a member of the Massachusetts Bar.







Jose Maria Ochave – Live case study presenter Senior Vice President of Unilab, Inc. Philippines

Jose Maria A. Ochave, LLM, is a member of the Executive Committee and Senior Vice President of Unilab, Inc., the largest pharmaceutical company in Southeast Asia. In Unilab, he heads the Business Development Group, Legal Services, and Regulatory Affairs, among others. He is also President RiteMed Philippines, Inc., Pharex Healthcare Corporation, and Synnovate Pharma Corporation.

Full biography

Jose Maria A. Ochave has been with Unilab, Inc. for 22 years. Aside from being a member of its Executive Committee, he heads various enabler units, including Business Development, which is responsible for identifying and negotiating collaborative agreements (e.g., licensing, supply, co-marketing) with other companies. As a chemical engineer and lawyer, he leads the initial technical and commercial due diligence of prospective partner companies. As such, he has visited and negotiated with over a hundred healthcare companies abroad for the purpose of making available their products in the Philippines.

As Head of Legal Services, Jose Maria leads crafted and implements the patent and licensing strategy of Unilab. Through the years, this has enabled the company to enter therapeutic segments and launch products well ahead of competitors. He was actively involved in the advocacy campaign to support the passage of the Cheaper Medicines Act of 2008, which amended the Intellectual Property Code of the Philippines to provide the public health flexibilities as recommended in the Doha Declaration and TRIPS and Public Health. This significantly expanded access to essential medicines in the Philippines and led to the establishment of new companies with novel business models.

Jose Maria is also a member of the Governing Council of the Philippine Council for Health Research & Development, a government agency under the Department of Science and Technology (DOST) responsible for funding university and government researches in healthcare. He is also the legal adviser of the DOST-Biosafety Committee, which regulates the entry and use of living modified organisms for use in the laboratory. He has worked in the area of biosafety regulation for more than 20 years and helped draft key regulations in the area.

He is a frequent speaker on intellectual property and licensing in the pharmaceutical sector, business model innovations, market entry strategies, among others, in foreign and local seminars and fora.

Jose Maria obtained his B.S. in Chemical Engineering and Bachelor of Laws degrees from the University of the Philippines–Diliman. He obtained his Master of Laws degree from the University of Michigan at Ann Arbor under a Clyde Dewitt fellowship.

She is Past President of LES Scandinavia and board member of LES International.

Sonja London is general counsel and licensing executive in Tactotek, world-leading innovator in the field of in-mold structural electronics. Her current role includes overseeing legal and strategy matter as well as IP and licensing strategies. Before joining Tactotek, Sonja worked with Nokia Patent Business for 14 years in various roles. In her latest position she was leading Nokia's Consumer Electronics licensing program; a global licensing program for connectivity and audio codecs for major consumer electronics categories. While steadily growing the program, Sonja has been deeply involved in major licensing negotiations in Asia, Europe and US and developed over-arching strategic vision, execution and enforcement plans for Nokia patent licensing.

Sonja has been deeply involved in licensing of various technologies (such as cellular, wifi, audio and video codecs) for mobile and infrastructure products and consumer electronics. Her experience also covers patent pools and joint licensing programs, business development as well as digitalizing and managing licensing business.

Sonja is known to be an advocate for digitalization and efficiency of business processes. She has lead Nokia Patent business to be a global role model in using new strategic business support technologies such as AI, automation and business intelligence solutions.
