- 5. The Select Committee last defined its approach to admitting observers from contracting states of the European Patent Organisation that are not EU member states participating in enhanced cooperation in the area of the creation of Unitary Patent Protection in document SC/34/13:
  - "(...) it is proposed to the Select Committee to admit as observer, on the basis of Article 6 (3) of its Rules of Procedure, one representative of each contracting state of the European Patent Organisation (...)."
