To request exemption from the nationality requirement, please file a letter of justification as well as pertinent proof of the special circumstances justifying such an exemption.

For proof of your place of business or employment, please file confirmation from your current employer or, for self-employed representatives, other appropriate evidence, e.g. proof of tax/business registration.
- 7 Failure to provide your telecommunication details to be used by the EPO and the epi may result in delays in the processing of your request and could also impede your future exchanges with the EPO and the epi.
- 8 Requesters with forthcoming oral proceedings will be handled with priority.
